- 3) Membership is not guaranteed. Membership is contingent on approval by a majority of the Board of Directors within 30 days of the application receipt by the club Secretary.
- 4) Upon approval, applicant will receive an orientation from a club designee which may include but is not limited to:
 - a. Reviewing all aspects of the field operation.
 - b. Review of AMA and PCMA safety rules.
 - c. Demonstration of proficiency in flight.

Club meetings are typically held as needed. The date and times are posted on the PCMA website and published in the newsletter.

THIS WAIVER DOES NOT AFFECT MY RIGHT TO ASSERT A CLAIM AGAINST AN INDIVIDUAL WHETHER A NONMEMBER OR AN AMA MEMBER, EVEN THOUGH IT DOES PROHIBIT ASSERTING ANY CLAIMS AGAINST THE CLUB, CLUB OFFICERS, THEIR AGENTS, THE SITE OWNER, AND/OR ANY OTHER SITE OWNER, AND ANY OTHER PERSONS OR ENTITY NOT DIRECTLY INVOLVED IN ANY CLAIM. NEITHER DOES THIS WAIVER HINDER OR LIMIT MY INSURANCE COVERAGE UNDER THE COMMERCIAL GENERAL LIABILITY COVERAGE AMA POLICY, OR PROHIBIT AN AMA MEMBER CLAIM UNDER THE AMA ACCIDENT/MEDICAL COVERAGE, OR FIRE, VANDALISM AND THEFT COVERAGE POLICIES.

For and in consideration of permitting the undersigned individual to become an active member and to be a spectator and/or participate in any way in the modeling activities at Paulding County Model Aviation, Inc., located in Paulding County, Georgia, the undersigned hereby voluntarily waives, releases, discharges and relinquishes any and all claims, actions or causes of action for personal injury, property damage, or wrongful death occurring to him/her arising as a result of radio control modeling activities incidental thereto wherever or however the same may occur and for whatever period. The Undersigned does, for him/herself, his/her heirs, executors, administrations and assigns, release, and for his/her estate, and agree that under no circumstances will he/she heirs, executors, administrators and assigns present any claim for personal injury, property damage or wrongful death against the Club, Club Officers, the site owners, and/or any other site owners involved and/or their officers, agents, servants or employees for any and all said claims, actions, or causes of action, whether the same shall arise by negligence of any said persons, or otherwise.

I recognize that safety equipment and safety procedures used are not totally effective in preventing injury or death, even when used and positioned according to instructions and common sense. While some level of protection is provided by safety equipment and safety procedure used there still remains the risk of injury or death. I also understand that I will be required to demonstrate my ability to safely fly my RC model to the satisfaction of the Club's Safety Officer prior to being allowed to fly solo.

I am also aware that modeling may present hazards to participants and/or spectators as a result of any number of factors, including, but not limited to, unpredictable deviations from flight plans, the use of flammable liquids for fuels, equipment with numerous moving parts, and the uneven terrain over which modeling may occur.

IT IS THE INTENTION OF THE UNDERSIGNED APPLICANT, BY THIS DOCUMENT, TO EXEMPT AND RELIEVE THE CLUB, PRESENT AND PAST CLUB OFFICERS, THE SITE OWNERS, AND THE ACADEMY OF MODEL AERONAUTICS, THEIR OFFICERS, AGENTS, SERVANTS, AND EMPLOYEES FROM ALL LIABILITY OF PERSONAL INJURY, PROPERTY DAMAGES AND/OR WRONGFUL DEATH CAUSED BY NEGLIGENCE.

This document is governed by the laws of the State of Georgia. In the event one or more clauses are found to be ineffective, the remaining clauses shall remain enforceable.
